# Access Fee Determination Central-West Orana Renewable Energy Zone

## 1 Introduction

## 1.1 Access Fees

- (a) In accordance with section 26 of the EII Act, this Determination sets out the Access Fees determined by the Consumer Trustee that are payable by the Access Right Holder to the Scheme Financial Vehicle to connect the Project to the Access Rights Network, which are set out in the Access Fee Schedule.
- (b) The Access Fee Schedule forms a part of this Determination.
- (c) The Access Fees set out in the Access Fee Schedule include escalation at 2.5% per annum, compounded quarterly.
- (d) The Consumer Trustee may vary the Access Fee Schedule in accordance with section 3 ("Variation Process") and revise the Access Fee Schedule in accordance with section 4 ("Revision to Access Fee Schedule") of this Determination.

## 1.2 Access Fee Calculator

The Consumer Trustee has determined, and will determine any variations to, the Access Fees using the Access Fee Calculator (Project) in accordance with this Determination.

## 1.3 Payment of Access Fees

The Access Right Holder must pay the Access Fees for the Payment Term in accordance with the Access Payment Deed.

#### 1.4 Access Fees exclusive of GST

- (a) Access Fees set out in the Access Fee Schedule are exclusive of GST.
- (b) If GST is payable, or notionally payable, on a supply made in connection with this Determination, then:
  - (i) this Determination and the Access Fees set out in the Access Fee Schedule remain valid; and
  - (ii) the payment, or notional payment, of GST will be in accordance with the Access Payment Deed.

## 2 Variation Events

A "Variation Event" is the occurrence of an event after the date of this Determination which results in a Changed Input Variable and gives rise to a change in the Access Fees.

## 2.1 Variation Event - Approved Maximum Capacity Change

- (a) An "Approved Maximum Capacity Change" occurs if the Infrastructure Planner approves a change to the Maximum Capacity in accordance with the Access PDA.
- (b) Subject to paragraph (d), an Approved Maximum Capacity Change may increase or decrease the Base Fee and CSS Fee.
- (c) The Changed Input Variable in the Access Fee Calculator (Project) is "Maximum Capacity".
- (d) A decrease to the Base Fee and CSS Fee due to an Approved Maximum Capacity Change is limited to up to 5% of each of the Base Fee and CSS Fee.

## 2.2 Variation Event - H2P Capex Change

- (a) An "H2P Capex Change" occurs if one of the following events occurs that results in a change to the Total H2P Capex:
  - (i) "Scope Change" (Access Right Holder initiated): occurs if the Infrastructure Planner approves a change to Project Characteristics or Key Project Equipment proposed by the Access Right Holder in accordance with the Access PDA, which results in a change to the Total H2P Capex;

- (ii) "Total H2P Capex Change" (Infrastructure Planner initiated): occurs if the Revised Total H2P Capex is lower than the Total H2P Capex, due to a decrease to either:
  - (A) H2P Capex claimed by the Network Operator under the Project Deed with the Infrastructure Planner; or
  - (B) IP Fees expensed by the Infrastructure Planner; or
- (iii) "Asset Sharing Event" (Infrastructure Planner initiated): occurs if an additional party with an Access Right will use the same H2P Asset as the Access Right Holder and has provided the "H2P Delivery Security" in accordance with that additional party's access payment deed.
- (b) An H2P Capex Change that is a Scope Change may increase or decrease the H2P Fee.
- (c) An H2P Capex Change that is a Total H2P Capex Change or Asset Sharing Event may only decrease the H2P Fee.
- (d) The Changed Input Variable for an H2P Capex Change in the Access Fee Calculator (Project) is "Total H2P Capex".
- (e) A change to the Access Fees due to an H2P Capex Change can only occur before the Negative PAC Sunset Date.

[Note to CFGs: 30 June 2025 is the current "Negative PAC Sunset Date", being the sunset date for pre-agreed scope changes in the Project Deed, and is also the date by which the full bonding for H2P (equal to 100% of Total H2P Capex) needs to be provided.]

## 2.3 Variation Event - CSS Capex Change

- (a) A "CSS Capex Change" occurs if one of the following events occurs that results in a change to the Total CSS Capex:
  - (i) "System Strength Assessment Change" (Access Right Holder initiated): occurs if the Network Operator conducts a system strength assessment of the Project [which comprises an Integrated Resource System] and the Infrastructure Planner approves a change to Project Characteristics proposed by the Access Right Holder in accordance with the Access PDA, which results in a change to the Total CSS Capex; or
  - (ii) Total CSS Capex Change" (Infrastructure Planner initiated): if the Revised Total CSS Capex claimed by the Network Operator under the Project Deed is lower than the Total CSS Capex and the decrease is more than 0.5% of the Total CSS Capex.
- (b) A CSS Capex Change may only decrease the CSS Fee.
- (c) The Changed Input Variable for a CSS Capex Change in the Access Fee Calculator (Project) is "Total CSS Capex".
- (d) A change to the Access Fees due to a CSS Capex Change can only occur before the Negative PAC Sunset Date.

## 2.4 Variation Event - Connection Term Adjustment

- (a) A "Connection Term Adjustment" occurs if the term of the ESCD:
  - (i) is increased or decreased in accordance with the ESCD; or
  - (ii) where the ESCD is executed after this Determination, is different to the Payment Term included in the Access Fee Calculator (Project).
- (b) A Connection Term Adjustment may increase or decrease:
  - (i) the H2P Fee due to re-amortisation of the Total H2P Capex;
  - (ii) the CSS Fee; and
  - (iii) the Non-C&E Fee component only of the Base Fee.

- (c) The Changed Input Variable for a Connection Term Adjustment in the Access Fee Calculator (Project) is "Payment Term".
- (d) A change to the Access Fees due to a Connection Term Adjustment can only occur before the Negative PAC Sunset Date.

#### 2.5 Variation Event - Scheme Term Extension

- (a) A "Scheme Term Extension" occurs if the term of the Access Scheme is extended in accordance with the Access Scheme Declaration.
- (b) A Scheme Term Extension may require payment of the Base Fee to continue for the period of the relevant extension of the Access Scheme.
  - [Note to CFGs: Scheme Term Extensions that also causes a Connection Term Adjustment will be varied under section 2.4.]
- (c) The Changed Input Variable for a Scheme Term Extension in the Access Fee Calculator (Project) is "Scheme End Date".

## 3 Variation Process

This section 3 applies if:

- (a) the Consumer Trustee has been notified by the Access Right Holder or the Infrastructure Planner that a Variation Event has occurred; or
- (b) the Consumer Trustee otherwise becomes aware that a Variation Event has occurred and has received confirmation from the Infrastructure Planner that the Variation Event has occurred.

[Note to CFGs: The Access PDA will contain obligations on the ARH and EnergyCo to notify the CT where a Variation Event is triggered.]

## 3.1 Information required by the Consumer Trustee

- (a) Where one or more Variation Events occur, the Consumer Trustee requires the following information in order to vary the Access Fees:
  - (i) details of the relevant Variation Event(s), including details of the document and contractual process under which the Changed Input Variable(s) resulted;
  - (ii) the Variation Date;
  - (iii) the Changed Input Variable(s); and
  - (iv) any other information required under the EII Act and any guidelines issued by the Consumer Trustee (if applicable).
- (b) The Consumer Trustee may:
  - (i) request that the Access Right Holder, the Infrastructure Planner and/or the Network Operator provide any information it requires under paragraph (a) and any further information relating to the relevant Variation Event(s); and
  - (ii) take any steps it reasonably considers necessary to verify the occurrence of, or accuracy of information it received relating to, the relevant Variation Event(s).

## 3.2 Variation of Access Fees

If the Consumer Trustee has received all information it requires under clause 3.1 ("Information required by the Consumer Trustee"), then, in accordance with the requirements of the EII Act and having regard to any guidelines issued by the Consumer Trustee (if applicable), the Consumer Trustee must:

 vary or re-amortise the Access Fee (as relevant) by using the Access Fee Calculator (Project) immediately prior to the Variation Date and substituting in the relevant Changed Input Variables; and (b) issue to the Access Right Holder a revised Access Fee Schedule in accordance with section 4 ("Revision to Access Fee Schedule").

## 4 Revision to Access Fee Schedule

## 4.1 Revised Access Fee Schedule

- (a) If the Consumer Trustee is required to revise the Access Fee Schedule under section 3.2 ("Variation of Access Fees"), then it must:
  - (i) provide the Access Right Holder with the revised Access Fee Schedule within 20 Business Days of receiving all information it requires under clause 3.1 ("Information required by the Consumer Trustee");
  - (ii) ensure the revised Access Fee Schedule includes the Variation Date; and
  - (iii) provide a copy of the revised Access Fee Schedule to the Scheme Financial Vehicle and the Infrastructure Planner.
- (b) The Consumer Trustee may only revise the Access Fee Schedule under this Determination where, and to the extent, the Access Fee has been varied or re-amortised in accordance with section 3 ("Variation Process").
- (c) The revised Access Fee Schedule forms a part of this Determination from the relevant Variation Date.
